HQ IS A COLLABORATIVE EFFORT IN GRAND RAPIDS, MI WHERE THE COMMUNITY RECOGNIZES THE UNACCEPTABLE GAPS IN CONNECTION FOR RUNAWAY AND HOMELESS YOUTH. HQ SEEKS TO BREAK THE CYCLE OF HOMELESSNESS BY PROVIDING A SAFE PLACE WHERE YOUTH CAN EXPERIENCE BELONGING AND REST AS THEY CONNECT TO HOUSING, COUNSELING, EMPLOYMENT, AND EDUCATION. IN THE PAST YEAR, 40% OF YOUTH WHO IDENTIFIED AS BEING UNEMPLOYED AND NEEDING SUPPORT BECAME EMPLOYED WHILE WORKING WITH HQ STAFF. HQ SERVED 433 YOUTH DURING THE YEAR.
